

Key notes on: Ventilation in pregnancy

- Pregnant women are unique in the ICU population with many special needs related to:
 - Adapted physiology of pregnancy
 - O Presence of the fetus
 - Potential for obstetric complications
- There is a lack of evidence on providing mechanical ventilation for pregnant women in ICU
 - Much is extrapolated from usual ICU care
 - Theoretical considerations based on adapted physiology and presence of fetus
